Dear Ms Lina Vogel,

I thank you for your letter of 2023-01-03 granting me an extension to respond to you. I will do this in time, but I have an import question for clarification.

I called Svea Hovrätt earlier today regarding my case, and I was told to contact you directly in this matter. In your letter of 2022-12-21, you are acting upon a case filed by Pan-Europejski-Sad-Arbitrazowy (PESA). I understand that I need to present evidence to you in my favor and then the case will go back to PESA, and possibly back to us again. On the phone, I asked whether you trust PESA, and the answer was that you have to, because it was *official*. I also understand that you will get back to them in writing.

My concern is the following. I have serious doubts that PESA is a legitimate organization. It sounds similar to Europejski Sad Arbitrazowy (ESA), which has the URL http://courtesa.eu/. By contrast, PESA has the URL https://pesa-court.org and this domain is owned by Villa Europa, which in turn is owned by Krzysztof Sienicki, the same person that is suing me.

I ask you herewith to clarify my concern before I can respond to the allegations. Let me also emphasize two things. (i) I understand the importance of reporting the case to the police. I have not done this yet, but I will. I also understand that the police may actively invest time in this because of the magnitude of the resources that are being mobilized here in Sweden. (I am aware of altogether four cases in Sweden, but so far you have only been involved in two. The other is by Henrik Hult, <hult@kth.se>, case number: Ö 11558-2.) In addition, there are multiple cases in Italy, Spain, Holland, Germany, Switzerland, and probably more. (ii) Villa Europa (and perhaps just Krzysztof Sienicki) has been involved in *multiple* cases of pretending to be another person. PESA is just one among several examples. By contacting PESA, you may get a response from Krzysztof Sienicki himself!
