American Chemical Society v. Krzysztof Sienicki / Villa Europa Claim Number: FA1712001764106

Respondent is not using the disputed domain name to make a *bona fide* offering of goods or services or for a legitimate noncommercial or fair use. Rather, Respondent is attempting to divert Internet users to the <<u>chemarxiv.org</u>> domain name in order to pass itself off as being associated with Complainant to financially profit.

Respondent has registered and used the <chemarxiv.org > domain name in bad faith. Respondent is disrupting Complainant's business by contacting Complainant's customers, while using the domain name to attract users to its own webpage for commercial gain. Further, Complainant sent Respondent a cease and desist letter, to which Respondent failed to respond.
