**Notariellt bestyrkt kopia av parternas avtal samt en svensk översättning av skiljedomsklausulen.**

**Översättning av skiljedoms klausulen i parternas avtal (Villa Europa Sp. z o.o. och Dr Axel Brandenburg), sidan 2 i avtalet, daterat den 30 sept. 2020.**

5. Parterna (en fysisk person Dr Axel Brandenburg och Villa Europa Sp. z o. o. o.) kommer utöver de avgifter som anges i punkt 3 ovan överens om och bekräftar att lösningen av tvisten, om den skulle uppstå, ska ske inför Pan-europejski Sąd Arbitrażowy (Pan-europeiska skiljedomstolen), ul. Marszałkowska 53/36, 00-676 Warszawa, Polen, EU, i enlighet med det förenklade skiljedomsförfarandet (punkt 6.2 i skiljedomsreglerna) vid denna domstol som gäller den dag då förfarandet inleds. Skiljedomsspråket ska vara polska och den lag som är tillämplig på avtalet ska vara den materiella polska lagen tillsammans med 1958 års New York-konvention och Uncitral-modelllagen. Antalet skiljemän ska vara en. Parterna ska begränsa möjligheten att inleda ett skiljeförfarande vid den alleuropeiska skiljedomstolen till ett belopp som inte överstiger 50000 euro (femtiotusen euro) vid förenklat skiljeförfarande (punkt 6.2 och bilaga B till skiljedomsreglerna). Parterna är överens om att genomföra skiljeförfarandet enbart på grundval av handlingar. Skiljedomstolens (namngiven ovan) korrespondens och handlingar ska riktas (vidarebefordras) till Dr Axel Brandenburg adress NORDITA, AlbaNova Univ. Center Nordita, Roslagstullsbacken 23, SE-106 91 Stockholm, Sverige, EU och [theoretical-geography-debates@vvoip-theoretical-geography-debates.org](mailto:theoretical-geography-debates@vvoip-theoretical-geography-debates.org) (Villa Europa sp. z o. o. o.) eller deras ombud, om de har utsetts. Parterna är också överens om att domstolshandlingar som krävs enligt domstolens skiljedomsregler och meddelanden som rör skiljedomsförfarandet ska levereras med rekommenderat brev via PostNord, (<https://www.postnord.se>) och/eller Poczta Polska ([www.poczta-polska.pl/](http://www.poczta-polska.pl/)) som skickas med någon form av leveransmetod som ger bevis på leverans genom regional service i Sverige och/eller Polen (Post Nord och Poczta Polska). 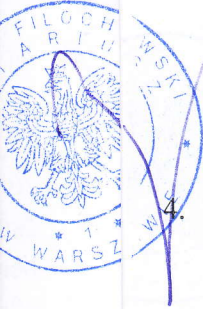

3. Marszałkowska 53/36, 00-676 Warszawa, Poland, EU, in accordance with Simplified Arbitration Procedure (point 6.2 Arbitration Rules) of that court in effect on the day the proceedings are commenced. The language of the arbitration shall be Polish and the law applicable to the contract shall be the substantive Polish law along with the 1958 N. Y. Convention and the UNCITRAL Model Law. The number of arbitrators shall be one. The parties shall limit the possibility of initiating arbitration proceedings before the Pan-European Arbitration Court to the amount of the claim not exceeding €50000 (fifty thousand €) in the case of Simplified Arbitration Procedure (point 6.2 and Anex B Arbitration Rules). The parties agree to conduct arbitration proceedings solely based on documents. The arbitration court (named above) correspondence and documents should be directed (forwarded) to Dr Axel Brandenburg adres NORDITA, AlbaNova Univ. 
