Clarifications regarding the allegation of Villa Europa

In the following, I present evidence that

- I was invited to what appeared to be a genuine scientific meeting (Figures 1–6 with emails of April and May 2020).
- (ii) The subsequent email conversation concerning copyright agreements appeared to follow standard procedure and *did not involve anything about payments* (Figures 2 and 4 with emails of May 13, 2020, and May 7, respectively).
- (iii) A 63-page letter, dated November 4, 2021, appeared to draw a connection between my lecture of April 24, 2020 and the copyright agreement with a claim that I agreed to a payment of 2785 euro (Figure 7 with a copy of a letter of November 2021). It also contained copies of a letter to my director, Niels Obers, who has never seen this until now. This appears to be fabrication of evidence (Figure 9).
- (iv) The authenticity of Villa Europa is questionable (Figure 8 with a screenshot of December 2022 showing the alleged location and the non-existence of the claimed website).
- (v) Villa Europa is not a trustworthy and credible organization; see the attachments demonstrating parallel allegations and investigations against them.

A list of 13 witnesses is included. It is followed by 7 additional names, including that of Professor Henrik Hult, who is being tried on similar charges.

1 Preamble

On April 8, 2020, I was contacted by "Matteo (Matt) Ferensby" (on behalf of the scientific committee) and asked to present a talk in the On-line Symposium "COVID-19 by the Numbers, Modes, Big Data, and Reality" on what was then to be April 15 through 16, 2020. This person gave as his address the University of Warsaw.

There is a question who "Matteo (Matt) Ferensby" actually is. He has no scientific record and was not present during the meeting that finally took place on April 24. There were 10 presentations on that day. I have been in touch with all of those participants during November 2021. All presenters have in common that they had papers on the arXiv, an online preprint platform; see below.

In hindsight, there is also doubt that the person "Anne Adamchewsky", who introduced herself as "a secretary/office person to the COVID-19 colloquium" really exists. (Another scientist, who gave a talk on another day, wrote me on Nov 4, 2021 that this person uses the face of another person.) She emailed me on May 13, 2020 saying that "I forwarded to you via traditional postal service some paperwork to be signed before (copyright, etc. issues)." (It is unclear what "before" refers to.) On May 24, 2020, she wrote "The youtube.com service requires us to clear the copyrights and publication issues, therefore please return our paperwork as soon as possible." The URL of the recording was given in that email and already publicly available at that time.

2 Evidence of usual, non-commercial communication

I did sign the paperwork, but, because my institute (Nordita) moved into another building, I didn't keep any copies. I can therefore not confirm that it contained anything about any expense, which was never mentioned anyway. But, according to a letter from "Sad Arbitrazowy Lewiatan" dated 28 October 2021




Figure 3: Evidence of usual, non-commercial communication: youtube recording published on May 24 and confirmation of receipt of documents.

In hindsight, there is no clear connection between who is meant by the organizers, the names "Matteo (Matt) Ferensby" and "Anne Adamchewsky", and "Villa Europa" that is mentioned in the signed document. This constitutes in my opinion intentional deception.

• The document with my signature, which only mentions in words "two thousand seven hundred




Figure 9: Evidence of fraud: Copies of a letter to my director, Niels Obers, dated April 2020, but sent to me in November 2021. Niels Obers has never seen this until now. This appears to be fabrication of evidence.

eighty five euro" instead of "2785.- euro". The fact that this is hidden in a 3-page long document (if it is even real!) is evidence of attempted deception. In fact, I have never been involved in any recording of a scientific presentation where the author has to pay.

- The statement "All participants ... of the Debate ... agree ... to furnish ..." is wrong. None of the other 9 speakers of that day have agreed to or performed any payment, nor have the speakers of other days paid them anything.
- Email correspondences showing that only scientists from the EU have been approached for payment. None of them have paid anything, Yet the recordings of all talks has been publicly available since April 2020 under https://www.youtube.com/@vvoip_theoretical_geograph821.

Subject: Removal of the webinar of October 23, 2020 - COVID-19 Disease Mapping with INLA

I received on January 29, 2021, by post (registered mail RR 428 075 217 PL) a proposal for an agreement (called "Consent to publish Video Recording and License Agreement") relating to a video-lecture I delivered upon invitation (with waived participation fees) within the web-based conference-debate "Covid-19 by the Numbers, Modes, Big data, and reality", organized by Mr. Matt Ferensby for "Spatial Bayesian Hierarchical Modelling" on October 23, 2020.

We verified that even if you stated that the participation to the conference was completely free and you asked by email to 'Fill by hand a few lines indicated by the color sticks and return in the attached envelope' about the document titled 'Consent to publish video recording and License Agreement', you have unilaterally and secretly modified it. I refer to paragraph 2.10 on pag. 6 of the agreement, reporting some costs that you ever mentioned before written by bad faith in letters and not as a well visible table of costs. In this form it cannot be retained acceptable by any part of a real loyal agreement, or further by any judge in Europe. I have not got any formal proof that you received a copy of this letter signed by me.

Moreover, you have continued to stalker me sending a document written in Polish titled 'Regulamin PESA' (RR 449

477 159 PL) and other letters in successive months.

Finally, the 10th of October 2022 I got an email by the address <u>anja.muller1996@gmail.com</u> to my job address, demanding an amount of money in the light of a court award you cite, still proposing an amicable approach to deal with this issue.

In light of this serious elements, no agreement can be considered finalized, and nothing is due from me.

The methods by which you have acted, both in the phase prior to the webinar (where no reference has ever been made to edition costs), and in the subsequent one of sending the documentation, seems to demonstrate a clear intention to obtain a consent through deception and tricks, in violation of all principles of fairness and good faith in the negotiations. My University formally notifies you to cease and desist from any attempt to obtain any cost. In addition, my University proceeded to lodge a complaint to the competent authorities.

Moreover, the postal police of Palermo issued an official complaint on the 10th of October 2022.

For these reasons, I order you to delete my intervention from your Youtube channel and your online platform and remove my name from your contacts and in association to your webinars.

I intimate and distrust you to fulfill the above, ailing that I announce you that I filed a police report complaint for stalking towards you.
