## Settlement Agreement Letter

Dear Dr. Gandini, we received an obscure letter claiming undocumented issues. **We do not agree with your comments**, and:

1. **You frets are indeed uncivilised** and it is you who abused our good will and who does not want to pay for services provided to you,
2. It is undocumented to claim that our web site did not provide all relevant information including participation fees and open access publication of your lecture. Please find the attached **a part** of a notary deed (**document**) of our website and 10<sup>th</sup> webinar. The provisions given their are **on the contrary** to your comments in your letter,
3. Therefore your "...legitimate inference..." is not even wrong. Dr. Gandini, could you refrain from a **straightforward lies**, no need for that. Let us stay within civilised frame,
4. Do not teach us what is Rome I regulation. I advise you to learn also what is European Payment Order and/or Small Claims Regulation,
5. We will make the use of the above law and sue you here in Regional Court in Grodzisk Mazowiecki (<http://www.grodzisk.sr.gov.pl/>),
6. **It is your choose and you can decide on a course of action**,
7. Let me assure you that the court will treat you as a professional who "... regularly participates to congresses, webinars, ..." and not a person who was not aware, lost, or who was "deceived" by us. If needed we will provide a complete list of your publications etc., for example: ([https://www.ieo.it/PageFiles/5240/CV\\_ieo\\_sara\\_gandini.pdf?epslanguage=it](https://www.ieo.it/PageFiles/5240/CV_ieo_sara_gandini.pdf?epslanguage=it)) and if you wish <https://silo.tips/download/curriculum-vitae-sara-gandini> We wonder how you will argue standing before the court that you are unprofessional person lost in the world & abused by us.
8. Come on Dr. Gandini, we are not asking you to pay "...for your work" [ridicules and regrettable comment in your letter]. We are asking (**and will sue you**) for participation fee (10<sup>th</sup> webinar) and our service to publish your lecture (<https://www.youtube.com/watch?v=vHbpsQXKu4Y>) given at the 10<sup>th</sup> webinar (as given in a notary deed of the web site),
9. Your account (of professional person) months after the event and after our work (service) completed "*May I ask if the publication is free of charge?*" or "*I'm sorry but it was not clear. I'm not going to pay anything.*" long after all service work has been done and agreed upon will not stand before the objective court.
10. We will file a case against you in one of the courts in Poland personally (**Dr. Sara Gandini, Via Lucca 2, 20152 Milano, Italy, EU - CF: GND5RA689A71E897L**) (Rome I, European Payment Order, European Small Claims Regulation-Procedure) and it will be your concern to follow the case, participate, hire the lawyer, pay the court fees, pay for travel, accommodation, translator (proceedings in Polish), etc. We will split the total balance into two parts (fee and open access). Your final costs are unknown now, however, as a general rule and due to your foreign nature the cost will round up about 4 (four) times the initial amount (point 1 above) and stay about €25,000, not including the cost of GLV.
11. We could consider easy installments if you request one.
12. Provided you kind assurances, we will be ready to furnish the invoice to your institution, provided certain additional fees.

**And now in less formal way, I wish to ask you to conclude and close this issue in an amicable way. It will take time to go for court decision, which will be in our favor. It will consume both sides time, effort, unpleasant situations and unwanted burden. If you feel confused by the situation, please accept our sincere apologies. No ill intentions were present. We worked hard to make the webinar running and it was successful event. Sara (if I may) could you please try to think in a positive way and let us close the issue right now. Do not respond right away, no need for that. Let us think that I will expect a news (good news) form you before the end of May. Consider point 12.**

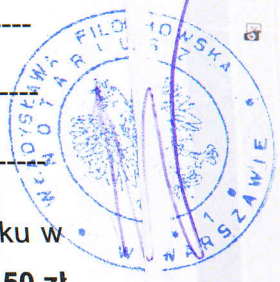

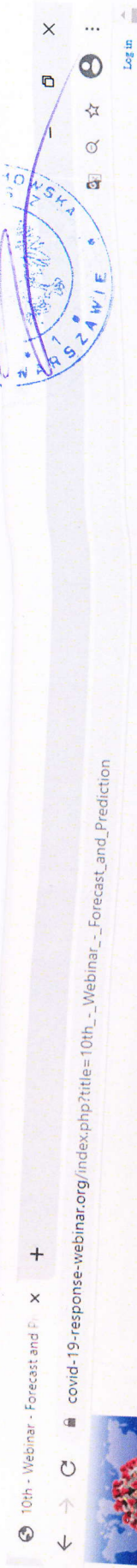

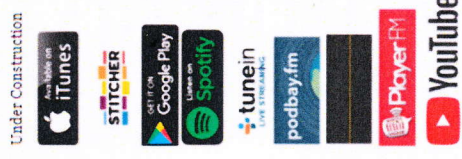

1.
